Will the Minister of **AYUSH** be pleased to state:

- (a) the details of AYUSH services being provided through upgradation of AYUSH hospitals and dispensaries, co-located Primary Health Centers (PHCs), AYUSH facilities in Community Health Centers (CHCs) and District hospitals; State/UT-wise;
- (b) the details regarding strengthening of institutional capacity at the State level through upgradation of AYUSH educational institutions, State Government ASU and H pharmacies, drug testing laboratories and ASU and H enforcement machinery established in the country, State/UT-wise;
- (c) whether the Government proposes to set up compulsory component AYUSH services, ASU and H quality control of medicines, medicinal plants, AYUSH educational institute in the country; and
- (d) if so, the details thereof, State/UT-wise, particularly in Koppal in Karnataka and Karnal and Sirsa in Haryana?

ANSWER

THE MINISTER OF AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY(AYUSH) (SHRI SARBANANDA SONOWAL)

(a): The Ministry of AYUSH provides financial assistance to State/UT Governments to upgrade the infrastructure and supply of essential AYUSH medicines to the AYUSH health facilities under the Centrally Sponsored Scheme of National AYUSH Mission (NAM). Out- Patient services are being provided through the AYUSH hospitals and dispensaries, co-located Primary Health Centers (PHCs), AYUSH facilities in Community Health Centers (CHCs) and District hospitals. In-Patient services are provided through AYUSH hospitals & District hospitals. The State/UT-wise status of supported AYUSH hospitals & dispensaries and co-located AYUSH units are furnished at **Annexure-I.**

- (b): Under the Centrally Sponsored Scheme of National AYUSH Mission (NAM), there is a provision of financial assistance for infrastructural development of AYUSH Under-Graduate & Post-Graduate Institutions for undertaking different activities like Construction of OPD/IPD/Teaching Departments/Library/Laboratories/Girls' Hostel/Boys' Hostel, procurement of equipment, furniture and library books. Under NAM Grant-in-aid was provided for strengthening of State/Govt. Ayurveda, Siddha, Unani and Homoeopathy (ASU&H) Pharmacies, State Drug Testing Laboratories of ASU&H Drugs and ASU&H Drug Control Framework. The State/UT-wise status of AYUSH Educational Institutions, State Government ASU and H pharmacies, Drug testing laboratories and ASU and H enforcement mechanism supported is furnished at Annexure-II.
- (c) & (d): The AYUSH services and AYUSH Educational Institute components have been approved by the Central Government for continuation under NAM from 01.04.2021 to 31.03.2026. However, the Quality Control of ASU and H drugs and Medicinal Plants components have been delinked from NAM. The State/UT wise resource pool has already been communicated for the year 2021-22 and States/UTs were requested to submit the State Annual Action Plans as per the NAM guidelines and felt need & priority of the respective State/UT Government. Further, under NAM, there is no District-wise allocation made to the States/UTs to the States/UTs including in the States Karnataka and Haryana.
