STEPS TO DEVELOP TEXTILE INDUSTRY

1979. SHRIMATI SANGEETA KUMARI SINGH DEO: DR. JAYANTA KUMAR ROY:

Will the Minister of TEXTILES वस्त्र मंत्री be pleased to state :

- (a) the steps undertaken by Government to develop textiles including funds allocated to the States of Odisha and West Bengal;
- (b) the details of e-commerce platforms of Government presently available for online marketing of handloom products in the said States;
- (c) the steps undertaken to encourage the growth of textiles in the said States which are facing competition from cheaper, machine-made textiles that are being imported;
- (d) the details of assistance provided to the rural craftsmen, sculptors and weavers in the said States during COVID pandemic times;
- (e) whether one "Craft Village" is proposed to be established in these States where the traditional craftsmen and weavers can stay and display their rich handicrafts, sculptures; and
- (f) if so, the steps being taken by Government in this regard?

THE MINISTER OF STATE IN THE MINISTRY OF TEXTILES (SMT. DARSHANA JARDOSH)

(a) & (c): Several steps have been taken by the Government to develop textiles throughout the country including states of Odisha and West Bengal. With a view to promote ease of doing business in the country and achieve the vision of generating employment and promoting exports by way of technology upgradation in textile sector through "Make in India". Amended Technology Upgradation Fund Scheme (ATUFS) was launched in January 2016 with an outlay of Rs. 17,822 crores from 2015-16 to 2021-2022. The objective of the scheme is to facilitate augmenting of investment, productivity, quality, employment, exports along with import substitution in textile industry and also to indirectly promote investment in textile machinery manufacturing. ATUFS is a demand driven scheme wherein funds are allocated pan-India basis instead of state-wise allocation of funds.

Government has recently extended the Rebate on State and Central Taxes and Levies for exporters of garment and made-up products. This will help promotion of manufacturing of garment and made up and will create additional employment opportunities.

Further, following projects have been implemented in the State of West Bengal and Orissa under scheme for Integrated Textile Park (SITP) and Scheme for Incubation Centre in Apparel Manufacturing (SIAM) for the development of textiles:

- **(b):** Altogether, 23 e-commerce entities have been engaged for online marketing of handloom products. These e-commerce platforms are available for all the weavers across the country including the weavers of Odisha and West Bengal States. The details of 23 e-commerce entities are given in **annexure-I**.
- (d): The Government of India, Ministry of Textiles is implementing various schemes for overall development & welfare of the rural craftsmen, sculptors and weavers across the country, including in the State of Odisha and West Bengal. Under these schemes, financial assistance is provided for raw materials, purchase of looms and accessories, design innovation, product diversification, infrastructure development, skill upgradation, lighting units, marketing of handloom & handicrafts products in domestic as well as overseas markets and getting loans at concessional rates, etc. Further, during COVID 2019 pandemic, artisans/ weavers are being registered on government e- marketplace (Gem) to sell their products on line.

Budgetary allocation of funds is not made State/UT-wise. Funds are directly released to the eligible agencies/weavers on receipt of viable proposals. However, scheme-wise funds allocated for the year 2021-22 for handlooms& handicrafts sector schemes are given in **annexure-II.**

(e) & (f): Government has established one craft village at Raghurajpur in Odisha where the traditional craftsmen and weavers can stay and display their rich handicrafts, sculptures of the State.
