Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) whether the Government has received any proposal from the State Government of Madhya Pradesh for environmental clearance of Government and Non-Governmental projects;
- (b) if so, the current status of the said proposal along with the details of such pending proposals, district wise; and
- (c) the reasons for pendency and the time by which the said proposals are likely to be approved?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

(a) to (c) As per available information on PARIVESH portal, as on date five (5) non-government proposals relating to the State of Madhya Pradesh, are being dealt at the Central level, and ninety seven (97) non-government and nine (9) government proposals are being dealt at State Environment Impact Assessment Authority (SEIAA) level. The details along with present status of the projects at Central Level is **annexed.**

The proposals for Environmental Clearance (EC) are processed as per the provisions laid down in the Environment Impact Assessment (EIA) Notification, 2006. As per the procedure prescribed in EIA Notification 2006, the complete proposals received are appraised by Expert Appraisal Committee (EAC) at Central level and by State Expert Appraisal Committee (SEAC) at State level. The recommendation of EAC and SEAC are considered by Ministry of Environment Forest and Climate Change at Central level and SEIAA at state level for approval. The decision on the project gets delayed due to various reasons viz. incomplete proposals, additional information sought by EAC/SEAC etc. However, overall time taken in grant of EC has been coming down steadily due to various efforts taken by Government towards streamlining the EC procedure.
