TIMELY PAYMENT TO WORKERS UNDER MGNREGS

2378. SHRI CHUNNI LAL SAHU:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number or people provided employment under Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) by the Government, if so, the details thereof;
- (b) whether payment to MGNREGA workers of Mainpur under Gariaband district of Chhattisgarh have been paid on time like other places in 2021, if so, the details thereof; and
- (c) whether there is any case of negligence in payment has come to the sight of the Government, if so, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) is a demand driven wage employment programme which provide for the enhancement of livelihood security of the households in rural areas of the country by providing at least one hundred days of guaranteed wage employment in every financial year to every household whose adult members volunteer to do unskilled manual work. In the current financial year 2021-22 (as on 31.07.2021), 6.78 crore persons were provided employment under Mahatma Gandhi National Rural Employment Guarantee Act (Mahatma Gandhi NREGA). In this regard, States/UTs-wise detail of the employment provided to persons under programme is given at **Annexure**.

(b) Mahatma Gandhi NREGS is a demand driven wage employment guarantee programme. During the current Financial Year 2021-22 (as on 31.07.2021), around 99.96 % Fund Transfer Orders (FTOs) have been generated within 15 days from the date of closure of the Muster Roll in the State of Chhattisgarh. The details of payment Fund Transfer order (FTO) generation for workers of Mahatma Gandhi NREGA of Mainpur under Gariaband district of Chhattisgarh have been provided by the State Government of Chhatisgarh as under:
