ASSISTANCE UNDER ODOP IN JHARKHAND

2469. SHRI SANJAY SETH:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) the districts in Jharkhand which have been provided assistance by the Central Government under “One District, One Product” (ODOP) scheme for agriculture sector; and
- (b) the details of the products exported under this scheme?

ANSWER

(a) For the One District One Product (ODOP), the Ministry of Food Processing Industries (MoFPI) under Centrally Sponsored Pradhan Mantri Formalisation of Micro Food Processing Enterprises Scheme (PM FME Scheme), in partnership with the States, provides financial, technical and business support for upgradation of existing micro food processing enterprises. This scheme is being implemented for a period of five years from 2020-21 to 2024-25 with an outlay of Rs. 10,000 crores. The district-wise products identified in the state of Jharkhand is **Annexed**. The scheme adopts ODOP approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products.

The Ministry of Agriculture and Farmers Welfare has planned to converge resources towards ODOP from ongoing centrally sponsored schemes such as Mission for Integrated Development of Horticulture (MIDH), National Food Security Mission (NFSM), Rashtriya Krishi Vikas Yojana (RKVY), Paramparagat Krishi Vikas Yojana (PKVY) etc. Similar approach has been suggested to Ministry of Fisheries, Animal Husbandry and Dairying for convergence of their schemes towards ODOP.

(b) ODOP programme is providing framework for value chain development and alignment of support infrastructure under PM-FME launched in 2020-21. For the state of Jharkhand, Government has allocated 6040 units for a period of five years (2020-21 to 2024-25) including current year target of 1359 units. The scheme is at initial stage and no products have been exported under PM-FME scheme.
