GRANTS TO VOs

256. MS. DIYA KUMARI:

Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) the details of grants allocated to Voluntary Organisations (VOs) and training institutions under the Grants-in-Aid scheme for the upliftment of backward classes during the last three years;
- (b) the detail list of voluntary organisations and training institutions working for the upliftment of the backward classes, particularly in Rajasthan, District-wise;
- (c) whether the Government monitors the expenditures incurred by these organisations for upliftment activities; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SUSHRI PRATIMA BHOUMIK)

(a): The Government through National Backward Classes Finance and Development Corporation (NBCFDC) facilitates Skill Development Training to the Other Backward Classes (OBCs) having annual family income below Rs. 3.00 lakhs. These skill programmes are undertaken by standard institutions and not by Voluntary organizations. The Skill Training programmes and grant allocated to Training Institutes during last 3 years is as under:

(b): This Ministry has no association with voluntary organisations for the skilling programmes. These training programmes are implemented primarily through Government and other reputed training institutes. The list of training institutes through which the skill development training programmes were conducted for NBCFDC's target group in the financial year 2020-21 in Rajasthan is enclosed.

(c) & (d): Monitoring of the training programme is done by the Corporation through participation is Selection Committee meetings, assessment process, surprise inspections, video call etc.

Further, the Corporation takes Utilization Certificate duly certified by the Chartered Accountant and statement of expenditure along with supporting documents from the Training Institutes.
