Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details and the number of people who have benefitted under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) since April 2020, State-wise, gender-wise, and discreetly mentioning new enrolments;
- (b) whether there has been an increase in enrolment in rural areas during and after the pandemic, if so, the details thereof;
- (c) the expenditure incurred from the start of the pandemic till now, the details on the usage of MGNREGS budgetary allocation during the last two years, State-wise;
- (d) whether some States have proposed changes in the scheme for its improvement and efficient implementation; and
- (e) if so, the details thereof including the feasibility of proposed changes?

(a)&(b): Details of State-wise and gender-wise number of persons provided employment under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) in FY 2020-21 and FY 2021-22 (as on 16.07.2021) is given at **Annexure-I.**

During financial year 2020-21, 1.87 crore new job cards were issued under Mahatma Gandhi NREGA which is 169% higher than the number of new job cards issued in the FY 2019-20, which was 69.53 lakh. The details of States/UTs-wise new job cards issued in FY 2020-21 and FY 2021-22 (as on 16.07.2021) is given at Annexure-II.
