- (a) whether the Government has conducted any survey/study to identify the number of people involved in the unorganised sector in India with Socio-religious Bifurcation;
- (b) if so, the details thereof;
- (c) if not, whether there is any proposal to do so in view of the observations made by different Commissions/Committees on the issue; and
- (d) if so, the distinctive features of the unorganised sector that could be identified from such study/survey?

(a) to (d): This Ministry has not conducted any survey/study to identify the number of people involved in the unorganized sector in India with socio-religious bifurcation. However, NSO, MoSPI has conducted survey on 'Unincorporated Non-Agricultural Enterprises (Excluding Construction)' during July, 2015 - June, 2016 (NSS 73rd round). In the survey, inter-alia information was collected on the social group of the owner or the major partner of the enterprise. The per 1000 distribution of enterprises by social group of owner / major partner for each State/UT (only for proprietary and partnership enterprises), is given in Annexure.
