(c) whether the Government, Post-GST implementation has directed Cantonments across the country to stop collecting Octroi and toll tax;

(d) if so, the details thereof and the status of implementation of the said order;

(e) whether despite of Government's orders, Secunderabad Cantonment Board is still collecting Octroi and Toll Tax; and

(f) if so, the details of action taken against those responsible?

## A N S W E R

MINISTER OF STATE IN THE MINISTRY OF DEFENCE (SHRI AJAY BHATT)

(a) & (b): Directorate General Defence Estates (DGDE) has informed that no Cantonment Board is presently collecting Octroi. Details of Octroi (prior to subsuming of

Octroi in GST w.e.f 01.07.2017) and Toll tax collected by Cantonment Boards (including Cantonment Board Secunderabad) during last five years including the current year are attached as **Annexure**. The Cantonment Boards not listed in the Annexure have not imposed Octroi or Toll tax during the last five years.

(c) & (d): Instructions were issued by DGDE vide letter dated 28.07.2017 that any tax/fee relatable to erstwhile Entry 52 of State List must not be imposed, having been subsumed in GST. It was further instructed that taxes on Vehicles and 'Tolls' relatable to Entries 57 and 59 of the State list have not been affected by introduction of GST. These instructions were issued in consultation with Department of Revenue, Ministry of Finance.

(e) Secunderabad Cantonment Board is not collecting Octroi after implementation of GST w.e.f July, 2017. It is collecting Toll tax in accordance with the instructions dated 28.07.2017 mentioned above.
