# LOK SABHA UNSTARRED QUESTION NO. 2906 TO BE ANSWERED ON 05 08 2021

#### JJM IN ASSAM

#### 2906. SHRI KRIPANATH MALLAH:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the salient features of the Jal Jeevan Mission (JJM);
- (b) the details of the funds sanctioned, allocated and utilized thereunder within Assam during the last three years and the current year;
- (c) the details of the tap water connections approved so far and work orders issued for connections during 2021-22;
- (d) whether the Government has made any survey for remaining households which are still without tap water supply within Assam;
- (e) if so, the details thereof, district-wise; and
- (f) the steps being taken by the Government to provide tap water connections to these households expeditiously?

#### **ANSWER**

## MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

- (a) Since August 2019, Government of India, in partnership with States, is implementing Jal Jeevan Mission (JJM) to make provision of tap water supply to every rural household of the country by 2024. The key features of the Jal Jeevan Mission (JJM) are to make provision of potable water to every rural household through tap water connection at a service level of 55 litre per capita per day (lpcd), of prescribed quality (BIS:10500) and on regular and long-term basis.
- (b) The details of Central fund allocated, released/ drawn by the State and reported utilization in Assam under the then National Rural Drinking Water Programme (NRDWP) in 2018-19 and under JJM in 2019-20, 2020-21 & 2021-22 is as under:

- (c) to (e) Drinking water supply is a State subject. Power to plan, design, approve, implement, operate and maintain water supply schemes is vested with States. As such, details of individual projects, *inter alia* which includes tendering process, etc. are not maintained by this Department. As reported by the State of Assam, the district-wise number of rural households that are yet to be provided with tap water supply are annexed
- (f) A number of steps have been taken to plan and implement JJM to make provision of potable tap water supply to rural households, schools, anganwadi centres, ashramshalas, etc. with speed, *inter alia*, which includes joint discussion and finalization of annual action plan (AAP) of States/ UTs including Assam, regular review of implementation of mission works, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc.

A detailed Operational Guidelines for the implementation of JJM; Margdarshika for Gram Panchayats & VWSCs to provide safe drinking water in rural households and Guidelines on 100–days campaign to provide piped water supply in anganwadi centres, ashramshalas and schools have been shared with States/ UTs, including Assam to facilitate planning and implementation of Jal Jeevan Mission.

For online monitoring, JJM-Integrated Management Information System (IMIS) and online JJM-Dashboard has been put in place. Provision has also been made for transparent online financial management through Public Financial Management System (PFMS).

Since launch of Jal Jeevan Mission in August, 2019, in Assam, so far 8.59 lakh (13.56%) rural households have been provided with tap water connections. Thus, as on date, 9.71 lakh (15.32%) rural households in the State have provision of tap water supply.
