TAP WATER ACCESS

2909. SHRI SUSHIL KUMAR SINGH:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether 10 million homes in encephalitis hot spots will be getting tap water access through Jal Jeevan Mission;
- (b) if so, the details thereof;
- (c) the peculiar features of the mission;
- (d) the details of the States that have performed better as compared to their counterparts in providing tapped water to households; and
- (e) the details of the States where the overall percentage of tap water connection are still low?

ANSWER

MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a)& (b) Government of India in partnership with States, is implementing Jal Jeevan Mission (JJM) to make provision of potable tap water supply to every rural household in the country, by 2024, inter alia which includes all households in JE–AES affected districts, on priority. As reported by 5 affected States, as on 02.08.2021, details of rural households having tap water supply in 61 (then 60) Japanese Encephalitis–Acute Encephalitis Syndrome (JE–AES) affected priority districts of 5 States, namely Assam, Bihar, Tamil Nadu, Uttar Pradesh and West Bengal, is at **Annex–I**.

(c) Jal Jeevan Mission is a decentralized, demand-driven and community-managed programme. Water supply system are to be operated and maintained by the Gram Panchayat or its sub-committee i.e. Village Water & Sanitation Committee (VWSC) or Pani Samiti, having 10–15 members with 50% women and proportionate representation to weaker sections of the village. Village Action Plan of each village is to be prepared which includes strengthening of drinking water sources, in-village water supply system, grey water management, and operation & maintenance for long-term water supply.

(d) & (e) State/ UT-wise details of rural households having provision of tap water supply and progress made in providing tap water connections to households since launch of JJM, is at **Annex-II.** The same is in public domain and available on the JJM dashboard at:
