(a) to (c): The Targeted Public Distribution System (TPDS) is governed as per provisions of the National Food Security Act, 2013 (NFSA) which provides for all India coverage of upto 75% of the rural population and upto 50% of the urban population which at Census 2011 come to 81.35 crore persons, for receiving subsidized foodgrains (Rice, Wheat and Coarsegrains). Coverage under the Act is under two categories- households covered under Antyodaya Anna Yojana (AAY) and the priority households (PHH) to be identified by the State Governments/ Union Territories (UT) Administrations as per criteria evolved by them, within the coverage limit determined for the State/UT. Under the Act, while Antyodaya Anna Yojana (AAY) households, are entitled to 35 kg of foodgrains per family per month, priority households are entitled to 5 kg of foodgrains per person per month at uniform subsidized prices of Rs. 3/2/1 per kg for rice/ wheat/ coarse grains respectively. The details of allocation and offtake of foodgrains in regard to States/UTs from year 2018-19 to 2020-21 under NFSA, are placed at Annexure-I.
