(a) to (d): Admissible amount of Provisional/Advance food subsidy is released to Decentralized Procurement (DCP) States such as Andhra Pradesh, based on their quarter-wise claims.

An admissible amount of Rs. 8424.72 Crore and Rs. 3303.39 Crore has already been released in FY 2020-21 and FY 2021-22 (till July'21) respectively to Andhra Pradesh as provisional and advance food subsidy including their claims of Pradhan Mantri Garib Kalyan Anna Yojana (PMGKAY), details of which are annexed.
