Will the Minister of SOCIAL JUSTICE AND EMPOWERMENT be pleased to state:

- (a) whether the Government had implemented the recommendations of Mandal Commission in 1990, if so, the details thereof;
- (b) whether there is any provision to give 27 percent reservation to the socially and economically backward people in Central Government jobs; and
- (c) if so, the details thereof regarding the number of people benefited from the reservation given in Governmental jobs from 1990 till date?

ANSWER

MINISTER OF STATE FOR SOCIAL JUSTICE AND EMPOWERMENT (SUSHRI PRATIMA BHOUMIK)

- (a) & (b): Yes Sir. As per recommendations of the Mandal Commission report, 27 percent reservation has been given to the Socially and Educationally Backward Classes (SEBC) (also known as the Other Backward Classes (OBC)) in direct recruitment to Central Government jobs and admission to Central Government Educational Institutions.
- (c): Department of Personnel & Training collects online data on representation and appointment of SCs/STs/OBCs w.e.f.01.01.2012 in the posts and services of the Central Government. Statements showing representation and appointment of reserved categories, including that of OBCs, w.e.f. 01.01.2012 to 01.01.2020, in the posts and services in the Central Government, as provided by various Ministries/Departments of the Government of India are enclosed.
