CHEMICAL CONTAMINATION OF DRINKING WATER

581. SHRIMATI SARMISTHA SETHI:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of the funds allocated under the National Rural Drinking Water programme during each of the last three years; State-wise;
- (b) whether 40 per cent of villages of the country are affected by chemical contamination of water;
- (c) if so, the details thereof, district and State-wise; and
- (d) the action taken by the Government in this regard so as to supply safe drinking water to each household?

ANSWER

MINISTER OF STATE FOR JAL SHAKTI (SHRI PRAHLAD SINGH PATEL)

(a) to (d) Since August, 2019, Government of India in partnership with States, is implementing Jal Jeevan Mission (JJM) – Har Ghar Jal after subsuming the then National Rural Drinking Water Programme (NRDWP), to provide tap water connection to every rural household by 2024 inter alia which includes quality-affected habitations/villages.Under JJM, habitations reported to have water quality issues in drinking water sources are given priority.

As reported by States/ UTs, as on 20.07.2021, out of 17.01 lakh with sources at a reasonable distance, 13.46 lakh [79.12%] rural habitations have provision of minimum 40 litre per capita per day (lpcd) of potable drinking water and 3.07 lakh [18.07%] rural habitations have service level of less than 40 lpcd potable water and 0.48 lakh [2.81%] rural habitations are reported to have water quality issues in drinking water sources. Out of these 0.48 lakh rural habitations, in 3,732 habitations have been covered through Community Water Purification Plants (CWPPs) as interim measure to provide safe drinking water to every household at rate of 8-10 litre per capita per day to meet their drinking and cooking requirement. District &State/ UT-wise details of remaining 0.44 lakh habitations reported to have water quality issues are at **Annex-I.**

The State/ UT-wise details of funds allocated, released and utilized for last three years i.e. under NRDWP in 2018-19 and under JJM in 2019-20 &2020-21 are at **Annex-II**.
