JAL SHAKTI ABHIYAN IN TAMIL NADU

643. SHRI GNANATHIRAVIAM S.

Will the Minister of JAL SHAKTI be pleased to state:

- (a) whether the Government has launched Jal Shakti Abhiyan;
- (b) if so, the details and features thereof along with the status of its implementation in various States in the country particularly for the State of Tamil Nadu and the funds allocated for the same, State and year-wise;
- (c) whether any steps are being taken by the Government to promote rain water harvesting and to minimize wastage of water in the country; and
- (d) if so, the details thereof?

ANSWER

THE MINISTER OF JAL SHAKTI

(SHRI GAJENDRA SINGH SHEKHAWAT)

(a) & (b) Ministry of Jal Shakti has taken up a nationwide campaign “**Jal Shakti Abhiyan - Catch the Rain**” (JSA: CTR) with the theme “*Catch the rain, where it falls, when it falls*” for creating appropriate rainwater harvesting structures in urban and rural areas of all the districts in the country including Tamilnadu, with people's active participation, during the pre-monsoon and monsoon periods. The campaign, primarily focusing on saving and conserving rainwater, was launched by Hon'ble Prime Minister on 22 March, 2021, the world water day. Creation of new and maintenance of old Rainwater harvesting structures; revival of traditional rainwater harvesting structures like stepwells etc; enumeration, geo-tagging, making inventory of water bodies, reuse and recharge of bore wells; watershed development, intensive afforestation, preparation of scientific water conservation plans and setting up of Jal Shakti Kendras are part of the campaign.

Ministry of Jal Shakti has allocated an amount of Rs. 2 lakh to each district including Tamil Nadu for preparation of GIS mapping and preparation of district water conservation scientific plan under JSA:CTR. Besides, funds are released to the State Governments under respective schemes of the concerned line Ministries.

The present status of progress made under the Jal Sahkti Abhiyan: Catch The Rain campaign during the period 22.03.2021 to 12.07.2021, as uploaded on JSA:CTR Portal (jsactr.mowr.gov.in) by the Central stakeholder Ministries/ Departments in respect of their Key Performance Indicators is available as **Annexure-I** to **Annexure-V**. State Governments have also been requested to upload the information regarding works undertaken by them with state and local funds under JSA:CTR campaign.

(c) & (d) Ministry of Jal Shakti has taken various steps for rainwater harvesting with community participation through different schemes viz. Atal Bhujal Yojana, National Aquifer Mapping Programme etc. National Water Policy (2012) inter-alia advocates conservation, promotion and protection of water and highlights the need for augmenting the availability of water through direct use of rainfall. 'Sahi Fasal' campaign, trainings, workshops, awards, seminars, water talks, exhibitions, fairs, competitions, webinars etc. for water conservation, water harvesting, water use efficiency and ground water management are also held with active participation of government departments, agencies, panchayats, non-government organisations etc.
