NUTRITIONAL STATUS OF WOMEN

764 SHRI NATARAJAN P.R.:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the names of Central Government schemes available to improve nutritional status of pregnant women and lactating mothers;
- (b) the eligibility criteria and salient features of benefits provided under the scheme;
- (c) the details of budget provision made/released/utilized during each year of the last four years including the current year, State and year-wise; and
- (d) the number of beneficiaries under the scheme since its inception and the expenditure incurred thereon during the last four years, State and year-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT
(SHRIMATI SMRITI ZUBIN IRANI)

(a) The specific targeted interventions being implemented by the Government to improve the nutritional status of pregnant women and lactating mothers under the umbrella Integrated Child Development Services Scheme (ICDS) throughout the country are as under:

1. Anganwadi Services Scheme
2. POSHAN Abhiyaan
3. Pradhan Mantri Matru Vandana Yojana (PMMVY)

(b) The eligibility criteria and salient features of benefits provided under the schemes are as under:

I. Anganwadi Services Scheme:

The beneficiaries under this scheme are children in the age group of 0-6 years, pregnant women and lactating mothers and following package of service is provided under the scheme:

- i. Supplementary Nutrition (SNP)
- ii. Pre-school Non-formal Education,
- iii. Nutrition & Health Education,
- iv. Immunization,
- v. Health Check-up, and
- vi. Referral Services

Three of the six services, viz., Immunization, Health check-up and Referral Services are related to health and are provided through NRHM & Public Health Infrastructure.

II. POSHAN Abhiyaan:

The aim of POSHAN Abhiyaan is to achieve improvement in nutritional status of children from 0-6 years, adolescent Girls, pregnant women and lactating Mothers in a time bound manner.

Key components of the Abhiyaan are as follows:

- i. Convergence
- ii. Use of technology
- iii. Community Mobilization and Behavioral Change
- iv. Jan Andolan
- v. Capacity Building
- vi. Incentives and Awards
- vii. Innovation

III. Pradhan Mantri Matru Vandana Yojana

The objective of the PMMVY is to provide partial compensation for the wage loss in terms of cash incentive so that the woman can take adequate rest before and after delivery of the first child and would also lead to improved health seeking behavior amongst the pregnant women & lactating mothers (PW&LM). The scheme envisages payment of maternity benefits of ₹5,000/- in beneficiary's bank/post office account linked to her Aadhaar Number in Direct Benefit Transfer (DBT) mode in three instalments. The eligible beneficiary is to receive the remaining cash incentive as per approved norms towards Maternity Benefit under Janani Suraksha Yojana (JSY) after institutional delivery so that on an average, a woman gets ₹6000/-.
