**ASSISTANCE TO STATES TO FIGHT COVID-19**

**777. ADV. DEAN KURIAKOSE:**

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether the Government has provided adequate financial assistance to States to check the COVID-19 Pandemic;
- (b) if so, the details thereof indicating the funds allocated for the purpose during the last one year;
- (c) whether the Government maintains any data of machineries/medicines donated by different countries to fight against the COVID-19 pandemic, if so, the details thereof, item and country-wise; and
- (d) the details of distribution of the said items, State/UT-wise?

**ANSWER

(a): Yes, All the States/UTs are provided with necessary financial support under **India COVID-19 Emergency Response and Health System Preparedness Package** has been approved for Rs 15,000 Cr by Cabinet on 22<sup>nd</sup> April 2020.

Under the Package, during the FY 2020-21, funds to the tune of Rs 8257.88 Cr has been released to the State/UTs through National Health Mission (NHM) framework. Rs 8257.88 Cr includes Rs 110.60 Cr towards payment of insurance of health workers. State-wise details are given at Annexure -I.

(b): Further, Operational cost was provided to States/UTs for vaccination of Health Care Workers and Front Line Workers under COVID-19 Vaccination Drive in the financial year 2020-21. State-wise details are given at Annexure -II.

(c) & (d): Yes, a database of relief material donated by different countries for COVID19 management during the second wave has been maintained. The item- and country-wise details can be accessed at MoHFW website (link: <https://main.mohfw.gov.in/node/5551>). The same have been distributed to all States/UTs of the country.
