Increase in Forest Areas

867. SHRI CHUNNI LAL SAHU:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of schemes being implemented by the Government to increase forest area in urban/rural areas during the last three years, State/UT-wise;
- (b) whether the Government is making constant efforts to promote plantation across the country; and
- (c) if so, the details and the outcome thereof, State/UT-wise?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI ASHWINI KUMAR CHOUBEY)

- (a)&(b) The Ministry has been making constant efforts to promote plantation across the country and has taken several initiatives to increase the forest and tree cover in rural and urban areas of the country as under:
 - i. The Ministry is implementing two major afforestation schemes namely National Afforestation Programme (NAP) for tree plantation in degraded forests through people's participation and National Mission for a Green India (GIM), An area over 2 million hectare was sanctioned for taking up afforestation in the States/Union Territories (UTs) with an investment of about Rs. 3936.41 crores till 2020-21 under NAP since its launch year 2000. Under GIM an amount of about Rs. 455 crore has been released to States/UTs since 2015-16 to 2020-21. The State-wise details of funds released during last three years (2018-19 to 2020-21) are given in Annexure I.
 - ii. The Government of India has disbursed an amount of Rs. 48477.77 crore from National Fund to 31 State funds as share of respective States as per Compensatory Fund Act, 2016 till 31.01.2021 for taking up various activities for improvement of forest area. State/UT wise details are given in Annexure I.
 - iii. The MoEFCC encourages plantation/ afforestation through people's participation under Nagar Van Yojana (NVY) for protection and development of urban forests. Rs. 14.10 crore has been released to 9 States for creation of Nagar Van during 2020-21 and 2021-22.

- iv. Further, tree plantation, being a multi-departmental, multi-agency activity, are also being taken up cross-sectorally under various programmes/funding sources of other ministries/ organizations and also through State Plan budgets.
- v. The Department of Agriculture Cooperation & Farmers Welfare (DAC & FW) is implementing Sub-Mission on Agroforestry (SMAF) under National Mission for Sustainable Agriculture (NMSA) since 2016-17 as part of the recommendation of the National Agroforestry Policy 2014 to promote plantation on farmlands. The scheme is being implemented in the States which have liberalized transit regulations for selected tree species. At present scheme is being implemented in 20 States and two UTs.
- vi. As per information received from Ministry of Housing and Urban Affairs, under Atal Mission for Rejuvenation and Urban Transformation (AMRUT), 1776 No. of parks over 3500 acres of land have been developed in the Mission cities which also contributed to the urban green cover.
- vii. Afforestation and tree planting activities, including in non-forest areas, are also taken up under various programmes/funding sources such as Mahatma Gandhi National Rural Employment Guarantee Scheme, Pradhan Mantri Krishi Sinchayee Yojana and under the schemes/plans of States and UTs.
- (c) The multi departmental efforts has yielded good results in conserving environment by addressing the problem of deforestation, besides keeping the pace of development, which is evident from the fact that the forest cover has stabilized and has been constantly increasing over the years. The latest 'India State of Forest Report (ISFR 2019) revealed that the total forest and tree cover of the country is 807,276 square kilometres (which is 24.56 percent of the geographical area of the country) compared to 802,088 sq km (24.39 percent) in ISFR 2017. This is an increase of 5,188 sq. km. of forest and tree cover combined, at the national level, as compared to the previous assessment i.e. ISFR 2017. The State/UT wise details of forest and tree cover as per ISFR,2019 is given in Annexure II.
