#### **IDENTIFICATION OF TOURIST SPOTS IN UTTAR PRADESH**

#### 95. SHRI UPENDRA SINGH RAWAT:

Will the Minister of TOURISM be pleased to state:

- (a) the details of the schemes being implemented for promoting tourism across the country including Uttar Pradesh;
- (b) whether the Government has identified any tourist spots for promoting tourism in Uttar Pradesh and if so, the details thereof;
- (c) whether the Government proposes to identify several ancient forts and sites in various districts of Uttar Pradesh and improve tourism sites; and
- (d) if so, the details thereof?

#### **ANSWER**

#### MINISTER OF TOURISM

(SHRI G. KISHAN REDDY)

(a) to (d): Development and Promotion is primary responsibility of State Governments /Union Territory Administrations. However, the Ministry of Tourism promotes India as a holistic destination through Domestic Promotion & Publicity including Hospitality scheme. Ministry as part of its on-going activities, releases print, electronic, online and outdoor media campaigns. In addition, promotions are also undertaken through webinars, Social Media accounts and Website of the Ministry.

The Ministry of Tourism, under the schemes of Swadesh Darshan, 'National Mission on Pilgrimage Rejuvenation and Spiritual, Heritage Augmentation Drive (PRASHAD), Assistance to Central Agencies for Tourism Infrastructure, provides financial assistance to State Governments/Union Territory (UT)

Administrations/Central Agencies for development of tourism infrastructure in consultation with them. The projects under these schemes are sanctioned subject to availability of funds, submission of suitable Detailed Project Reports, adherence to scheme guidelines and utilization of funds released earlier etc. Sanctioning of projects under these schemes is a continuous process.
