SHRI HEMANT SRIRAM PATIL:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of developmental projects of Maharashtra Government awaiting environmental clearance from the Union Government;
- (b) the average time taken in deciding on the clearance for developmental activities like roads and bridges;
- (c) the number and other details of National Highway projects stuck/stopped so far due to non-clearance from the Ministry; and
- (d) the details of actions taken by the Union Government to fast-track decisions on clearance requests on such development projects?

ANSWER

MINISTER FOR ENVIRONMENT, FOREST AND CLIMATE CHANGE (SHRI. BHUPENDER YADAV)

(a) to (d): A statement is laid on the Table of the House.

Statement referred to in reply to parts (a) to (d) of Lok Sabha Starred Question No. 11 to be answered on Monday, the 29thNovember, 2021 on "Environmental Clearance to Developmental Projects' by SHRI VINAYAK RAUT and SHRI HEMANT SRIRAM PATIL

- (a) As on date, Sixteen(16) proposals (excluding mining proposals) relating to State of Maharashtra, are being dealt at the Central level. Five Hundred Two (502) proposals (excluding mining proposals) are being dealt at state level by State Environment Impact Assessment Authority (SEIAA), Maharashtra, as per information available on PARIVESH. The details along with present status of the projects at Central Level isat **Annexure I**.
- (b) The average time taken at central levelfor granting environmental clearance to developmental activities like roads for the year 2020 and 2021 is 93 days. Average time taken by SEIAA, Maharashtra for granting environmental clearance to developmental activities for the year 2020 and 2021 is 130 days.
- (c) Presently thirteen (13) proposals of National Highway projects are being dealt at the Central level, out of which one (1) proposal is new, three (3) proposals have been recommended by Expert Appraisal Committee (EAC)and nine (9) proposals have been approved by the Ministry; subject to submission of Stage –I Forest Clearance from the project proponent. The details of the proposals are enclosed as **Annexure-II**. There is onlyone project in this list from the State of Maharashtra.
- (d) With a view to expedite the Environment Clearance (EC) process, a number of steps have been taken by the Central Government, which includes following:
 - i. Ministry has launched a single window online PARIVESH (Pro-Active and Responsive facilitation by Interactive, Virtuous and Environmental Single-window Hub) portal on 10th August, 2018 which automates the entire process of EC starting from submission of application, preparation of agenda, preparation of Minutes to grant of clearances.
 - ii. Expert Appraisal Committee (EAC) meetings for appraisal of projects are now conducted twice a month.
- iii. Various initiatives have been taken by the Ministry towards necessary amendments in the policies, and regulations to ensure transparent and simplified process of EC without compromising on rigor of the environmental concerns.

Due to various efforts taken by Government towards streamlining the EC procedure, overall time taken in grant of EC has been coming down steadily.
