**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) whether the Government has recently launched a national database e-SHRAM portal ([eshram.gov.in](http://eshram.gov.in)) with a unique Universal Account Number for the overall welfare of the unorganised workers in the country and if so, the details thereof;**
- (b) the number of labourers/workers registered so far on e-SHRAM portal since its launch, State-wise;**
- (c) whether the Government's pension plan and a life insurance scheme could be among the initial schemes linked to the Portal and if so, the details thereof; and**
- (d) whether the Government has approved the proposal for setting up an Employees' State Insurance Corporation hospital in Dholera Special Investment Region and if so, the details thereof along with the other steps being taken by the Government in this regard?**

**STATEMENT REFERRED TO IN REPLY TO PART (a) TO (d) OF LOK SABHA STARRED QUESTION NO. 114 TO BE ANSWERED ON 06.12.2021. REGARDING e-SHRAM PORTAL FOR UNORGANISED WORKERS RAISED BY SHRI BHOLA SINGH AND SHRI VINOD KUMAR SONKAR.**

**(a) to (c): On 26.08.2021 Ministry of Labour & Employment has launched e-SHRAM portal which is a National Database of the Unorganised Workers. It has been made available to the States/ UTs for registration of unorganised workers on e-SHRAM portal. As on 01.12.2021, 10.06 crore unorganised workers have already been registered on e-SHRAM portal. The detail of State wise registration of unorganised workers is annexed. All eligible registered unorganised workers are entitled to get benefit of an accidental insurance cover of Rs. 2.0 Lakh for a year free of cost through Pradhan Mantri Suraksha Bima Yojana (PMSBY). The registered workers on e-SHRAM are also nudged to take benefit of PM-SYM & NPS-Traders Pension Schemes.**

**(d): ESI Hospitals are set up in ESI notified areas on the basis of number of Insured Persons in the catchment area, as per norms. At present, the Dholera Special Investment Region, Gujarat is not notified for coverage under Section-1(3) of ESI Act, 1948.**
