- (e) if so, the details thereof?

STATEMENT REFERRED IN REPLY OF LOKSABHA STARRED QUESTION NO. 132 PART (a) to (e) ON NATIONAL LIVESTOCK MISSION PORTAL

(a) & (b) Online portal for National Livestock Mission (NLM) has been launched on September 06, 2021 during the national level consultation meeting with State Animal Husbandry Ministers.

Department of Animal Husbandry & Dairying (DAHD) is implementing National Livestock Mission, which aims towards employment generation, entrepreneurship development, increase per animal productivity, feed and fodder development targeting increased production of meat, goat milk, egg and wool and mitigating the demand and supply gap of feed and fodder. In order to facilitate the beneficiaries to submit their application under entrepreneurship programme and also to facilitate the State Government to submit their proposals for seeking assistance under National Livestock Mission, the online portal www.nlm.udyamimitra.in has been developed and launched.

- (c) This portal will increase the effectiveness and transparency in the overall scheme implementation process. The portal enables a customized "End to End digital workflow amongst Applicants to submit the application, State Implementing Agency (SIA) to screen and process the applications, Lenders to process the loan applications, State Level Executive Committee (SLEC) to approve and recommend the proposals for subsidy claim, and sending of subsidy to the beneficiary by Central Government directly to the beneficiary account through Small Industries Development Bank of India (SIDBI). This portal enables the beneficiaries to reach to the handholding agencies for preparation of various scheme documents required for loan from the Bank and Knowledge sharing etc. The beneficiaries can also able to know the status of their application submitted in the portal. Thus the portal will provide a seamless "End to End digital journey" experience to the entrepreneurs, Lenders, State and Central agencies with full transparency and utmost ease.
- (d) & (e) The Central Government has approved implementation of a **Livestock Sector Package** consisting of several activities by revising and realigning various components of existing schemes in order to have focused development of animal husbandry and dairying across the country for next 5 years starting from 2021-22. This package envisages Central Government's support amounting to Rs.9800 crore over duration of 5 years for leveraging total investment of Rs. 54,618 crore for 5 years.
