- (a) whether the Government has the data on foreign companies that have closed their industrial operations in the country since 2014;
- (b) if so, the details thereof including the reasons for closure of several foreign industrial operations in the country;
- (c) whether the Government has the data on existing industrial operations of foreign companies in the country and if so, the details thereof, State/ UT-wise;
- (d) whether the Government has the data on industrial operations by foreign companies that are attracted to 'Make in India' scheme and are still operating in the country; and
- (e) if so, the details thereof?

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF THE LOK SABHA STARRED QUESTION NO. 148 FOR ANSWER ON 08TH DECEMBER, 2021.

(a) & (b): There are two types of foreign entities registered in India, (i) Companies who have registered a liaison/branch office/ Project Office in India but incorporated outside India (ii) Subsidiaries of foreign companies Incorporated in India. These subsidiary companies are registered in India under the provisions of Companies Act, 2013. During the period from 2014 to 2021 (till November 2021), 10,756 foreign companies have registered with Liaison/ Branch Office/ Project Office in India and with their subsidiaries.

During the period from 2014 to 2021(till November 2021), 2,783 foreign companies registered with Liaison/Branch office/ Project Office and their subsidiaries have closed their operations in India for various reasons such as completion of business objectives/ projects, restructuring by Parent Company, amalgamation, and other management decision.
