- (a) whether the Government has received any representation through the public representatives to allow Central Public Sector Undertakings to utilise the City Gas Distribution (CGD) network of Geographical Areas (GAs), as a common carrier to supply Liquefied Natural Gas (LNG) wherever the tenure of marketing exclusivity period is over including Rajkot and Morbi GAs;
- (b) if so, the details of action taken thereon;
- (c) the details of marketing exclusivity period of CGD of Rajkot and Morbi GAs;
- (d) the details of GAs where the marketing exclusivity period is over, State-wise; and
- (e) the details of existing operator in charge where the marketing exclusivity period is over, State-wise?
