- (a): Presently, no Centrally Sponsored Scheme is being implemented by the Department of Sports. However, the Department of Sports, through the following Central Sector Schemes, supplements efforts of the State/UT Governments for development and promotion of sports: (i) Khelo India; (ii) Assistance to National Sports Federations; (iii) Special Awards to Winners in International sports events and their Coaches; (iv) National Sports Awards, (v) Pension to Meritorious Sports Persons; (vi) Pandit Deendayal Upadhyay National Welfare Fund for Sportspersons; (vii) National Sports Development Fund; and (viii) Sports training centres through Sports Authority of India (SAI). Details of these schemes are in the public domain on the websites of this Ministry and SAI.
- (b) and (c) Details of funds allocated and expenditure incurred under the schemes mentioned in part (a) during each of the last three years and the current year are given at Annexure. The Department of Sports does not maintain sports-wise allocation of funds.
