# STATEMENT REFERRED TO IN REPLY TO PARTS (a) & (b) OF LOK SABHA STARRED QUESTION NO. 35 DUE FOR REPLY ON 30<sup>TH</sup> NOVEMBER, 2021.

- (a): Yes, Sir. 'Har Medh Par Ped' Scheme is being implemented in those States that have liberalized felling and transit-regulations. Presently, the scheme is being implemented in 23 States/UTs with a view to encourage agro forestry i.e. tree plantation on farm land along with crops/ cropping system to help the farmer get additional income and make their farming system more climate resilient and adaptive.
- (b): The detail of year-wise physical achievements under the scheme from 2016-17 to 2020-21 is as under:
