Non-Availability of Digital Infrastructure

115. SHRI VINCENT H. PALA:

Will the Minister of EDUCATION be pleased to state:

- (a) the data on the number of school-going children deprived of digital infrastructure owing to the COVID-19 pandemic before re-opening of schools, State-wise;
- (b) the data on school dropouts due to the COVID-19 pandemic, State-wise; and
- (c) whether the Government has initiated any study on the long-term impacts of the loss of in-person teaching on the learning outcomes and if so, the details there of?

ANSWER

MINISTER OF EDUCATION (SHRI DHARMENDRA PRADHAN)

- (a) School Education is in the Concurrent List of the Constitution. The percentage of children in Kendriya Vidyalaya having access to digital devices is 98% and with Navodaya Vidyalaya is 93%. A comprehensive initiative called **PM eVIDYA** has been initiated as part of Atma Nirbhar Bharat Abhiyaan on 17th May, 2020, which unifies all efforts related to digital/online/on-air education to enable multi-mode access to education. The initiative includes:
 - DIKSHA (one nation, one digital platform) is the nation's digital infrastructure for providing quality e-content for school education in states/UTs and QR coded Energized Textbooks for all grades are available on it.
 - One earmarked Swayam Prabha TV channel per class from 1 to 12 (one class, one channel).
 - Extensive use of Radio, Community radio and CBSE Podcast- Shiksha Vani.
 - Special e-content for visually and hearing impaired developed on Digitally Accessible Information System (DAISY) and in sign language on NIOS website/ YouTube.

All these schemes/programmes are available to all the students across the nation.

(b) The State/UT wise data regarding annual average dropout is available at serial No. 17 (Id 4017) with sub-heading **enrollment** of the UDISE++ link mentioned below: https://dashboard.udiseplus.gov.in/#/reportDashboard/sReport

(c) The Government of India has been implementing a rolling programme of sample based National Achievement Survey (NAS) aimed at classes III, V, VIII and X under Samagra Shiksha since 2001 with a cycle period of three years.

NAS 2021 has been held on 12.11.2021 and has covered (a) Government Schools (Central Government and State Government); (b) Government Aided Schools; and (c) Private Unaided Schools.

The objective of NAS 2021 is to evaluate children's progress and learning competencies as an indicator of the health of the education system. National, State/UT and District Report cards are released to enable analysis of results and remedial action at the appropriate levels.
