Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

a) whether the Government has received applications for setting up training partner centres of Media and Entertainment Skill Council (MESC) centers in various states especially in the North Mumbai Parliamentary constituency of Maharashtra State during last three years;

b) the dates on which the applications were received for setting up the said centres especially in North Mumbai Parliamentary constituency during the above period till date;

c) the details of the number of applications approved and lying pending out of the applications received as on date especially of North Mumbai parliamentary constituency; and

d) if so, the details thereof along with the time by which these applications are likely to be approved?

(a) Yes, Sir. To set-up the training partners centers, the process is driven through centralised portal that is "Skill India Portal (SIP)" managed by National Skill Development Corporation (NSDC). As per the application details for Media and Entertainment Sector as available in the SIP, there are 825 such applications out of which 133 are from Maharashtra during last three years.

(b) During the period, in North Mumbai Parliamentary constituency 10 applications have been received on 28/Sep/2019, 22/Oct/2019, 10/Feb/2020, 19/Feb/2020, 23/Mar/2021, 8/Apr/2021, 22/Jun/2021, 28/Jun/2021, 13/Jul/2021 and 12/Oct/2021.
