**FOREIGN INVESTMENT**

**1301. SHRI SADASHIV KISAN LOKHANDE:**

**Will the Minister of Finance be pleased to state:**

- (a) the quantum of foreign investment in the country so far during the last three years, State-wise;
- (b) the shortfall or abundance seen during the said period, state-wise;
- (c) whether there is a shortfall in foreign investment in the country due to administrative obstacles; and
- (d) if so, the steps taken or proposed by the Government to deal with such obstacles in order to increase the foreign investment in the country?

a & b). The state-wise details of FDI Equity inflow are maintained w.e.f. October, 2019 onwards. Accordingly, the financial year wise details of state-wise FDI Equity inflow reported in the country since October, 2019 are attached herewith at Annexure 1.

c & d). The FDI equity inflows have increased in 2018-19 to 2020-21 period as given in table below:

Further, the Government has put in place a liberal and transparent policy for FDI, wherein most of the sectors are open to FDI under the automatic route.
