The Ministry of Tourism (a) and (b): provides financial assistance the State Governments/ Union Territory to Administrations/ Central Agencies under its schemes 'Swadesh 'Pilgrimage Rejuvenation and Spiritual, Heritage Darshan' and Augmentation Drive' (PRASHAD). In addition, financial assistance is also provided to Central Agencies for tourism infrastructure development. No project has been sanctioned in Sitamarhi under the above mentioned schemes.
