Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has any proposal to have a Mega Food Park in Western Odisha and Jharkhand, if so, the details thereof;
- (b) whether the Government is planning a second phase of implementation of the mega food park scheme, if so, the details thereof;
- (c) whether the Government has conducted any survey in Odisha for assessment to set up Food Processing Industries;
- (d) if so, the details of potential in the State with regard to food processing sector;
- (e) whether the Government has set up any food testing lab in Odisha; if so, the details thereof; and
- (f) whether the Government has any proposal to promote FDI in food processing in Odisha; if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (SHRI PRAHLAD SINGH PATEL)

- (a) & (b): Ministry of Food Processing Industries has accorded approval to 41 Mega Food Park Project in the country including 02 Mega Food Park Projects in the State of Odisha in Rayagada and Khorda Districts. Presently, there is no proposal under consideration in the Ministry to set up a Mega Food Park in Western Odisha and Jharkhand. The Ministry is not planning a second phase of implementation of the Mega food park scheme.
- (c) & (d): The Ministry has not conducted any survey in Odisha for assessment to set up Food Processing Industries.
- (e): The Ministry provides financial assistance to set up Food Testing Lab in the country under the scheme of Food Safety and Quality Assurance Infrastructure. The details of Food Testing Lab approved by the Ministry are at **Annexure**.
- (f): 100% Foreign Direct Investment (FDI) is permitted for the food processing sector in the country. To facilitate investment in the food processing sector, an Investment Targeting and Facilitation Desk is functional in the Ministry.
