- (d) the year-wise budgetary data for food security and distribution from 2014 till date?**

(a) & (b): In order to ensure proper functioning of the National Food Security Act 2013 (NFSA), reforms in the Targeted Public Distribution System are being undertaken in consonance with Section 12 of the Act. Some of these reforms include digitization of ration cards / beneficiaries database, seeding of unique identification numbers (Aadhaar) in digitized database, online allocation of foodgrains, computerization of Supply Chain Management, automation of Fair Price Shops, portability of ration cards, full transparency of records and putting in place of a strong grievance redressal machinery.

(c): The Public Distribution System (PDS) under NFSA evolved as a system of management of scarcity through distribution of foodgrains at affordable prices. PDS has become an important part of Government's policy for management of food economy in the country. PDS is operated under the joint responsibility of the Central and the State/UT Governments. The Central Government, through Food Corporation of India (FCI), has assumed the responsibility for procurement, storage, transportation and bulk allocation of food grains to the State Governments. The operational responsibility including allocation within State, identification of eligible families, issue of Ration Cards and supervision of the functioning of Fair Price Shops (FPSs) etc., rest with the State Governments. Total 5.44 lakh fair price shops exist across the country for distribution of foodgrains to the NFSA beneficiaries.

Quantity of foodgrains allocated and distributed under NFSA since 2014-15 is at Annexure - I.

The National Food Security Act, 2013 (NFSA) currently mandates a coverage of upto 75% of the rural population and upto 50% of the urban population, which at Census 2011 comes to 81.35 crore persons. Presently, approx 79.53 crore persons are covered under NFSA. Identification of beneficiaries under the Act is a continuous process. Details of number of beneficiaries covered under NFSA since 2014 is at Annexure-II.

(d): Details of year-wise budget allocated and fund released since 2014 as Food Subsidy to FCI, Food Subsidy to DCP States and Central assistance for expenditure incurred towards intra-State transportation and handling & FPS dealers margin is at Annexure - III.
