**REGISTRATION UNDER E-SHRAM PORTAL**

**168. SHRI ARVIND GANPAT SAWANT:**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) the details of numbers of beneficiaries registered under E-shram Portal till date, State/district-wise;**
- (b) details of total number of E-shram cards issued in the State of Maharashtra, district-wise along with the details of bank account seeded E-shram cards;**
- (c) whether the Government will share the unorganized labourers data with State governments; if so, whether the Government has envisaged data sharing security measures for the same; and**
- (d) whether the Government is planning for linkage of One-Nation-One-Ration Card, E-Shram Card (especially bank account seeded) and the Election Commission Card for furthering benefits to the unorganised labourers?**

**ANSWER**

**MINISTER OF STATE FOR LABOUR AND EMPLOYMENT  
(SHRI RAMESWAR TELI)**

**(a) to (d): Ministry of Labour & Employment has developed e-SHRAM portal which is a National Database of the Unorganised Workers seeded with Aadhaar. It has been launched on 26.08.2021 and made available to the States/ UTs for the registration of unorganised workers on e-SHRAM portal. As on 23<sup>rd</sup> November, 2021, 8.97 crore unorganised workers have been registered on e-SHRAM portal. The details of State wise registered unorganised workers as on 23.11.2021 is at Annexure-I. There are 19,70,974 unorganised workers registered in the State of Maharashtra so far. The District wise details of unorganised workers registered in the State of Maharashtra on e-SHRAM portal as on 23.11.2021 is at Annexure-II. One of the key objectives of the portal is to deliver the benefits of Social Security Schemes of Central and State Governments through e-SHRAM portal.**
