MOBILE SERVICES IN LWE AREAS

1806. SHRI BENNY BEHANAN:

Will the Minister of COMMUNICATIONS be pleased to state:

- (a) the number of villages in rural areas and areas affected by Left Wing Extremism (LWE) in the country which are yet to be connected with mobile telephone and internet services, as on date, State/UT-wise;
- (b) the schemes/programmes implemented by the Government to ensure mobile and internet services in each village of the country; and
- (c) the details of the funds provided by the Government under the said schemes/programmes during each of the last three years and the current year, State/ UT-wise and the Schemes/Programme-wise?

ANSWER

MINISTER OF STATE FOR COMMUNICATIONS (SHRI DEVUSINH CHAUHAN)

- (a) As per data provided by Telecom Service Providers (TSP) and field units of the Department of Telecommunications, as of December 2020, it is estimated that out of 5,97,618 inhabited villages (as per census 2011) of the country, 25,067 villages including areas affected by Left Wing Extremism do not have mobile and internet coverage. The State/UT wise status of mobile and internet connectivity in the villages of the country is enclosed as **Annexure-I**.
- (b) The details of major Government Schemes funded by Universal Service Obligation Fund (USOF) for mobile and internet connectivity is placed as **Annexure-II**.
- (c) Scheme-wise and State-wise details of disbursement of Funds for USOF schemes for providing Mobile and Internet Services during last three years (2018-19 to 2020-21) and current year 2021-22 (upto Oct., 2021) are enclosed as **Annexure-III & IV.**
