- (a) whether the Government has launched SAMBHAV National Level Awareness Programme, if so, the details thereof and the aims and objective behind the move;
- (b) the number of students from various colleges who participated in the programme;
- (c) the funds allocated and utilized for the programme;
- (d) whether the Government is conducting various training programmes under Entrepreneurship cum Skill Development programme (ESDP) across the country and if so, the details of such ESDP conducted during each of the last three years and the current year in the State of Tamil Nadu and Maharashtra;
- (e) the number of youth trained during each of the last three years in MSME sector, State/UT-wise; and
- (f) the other steps taken by the Government to encourage students from different colleges to take up entrepreneurship?

### **ANSWER**

# MINISTER OF MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI NARAYAN RANE)

- (a) to (c): 'Sambhav' e-National level Awareness Programme is being implemented by the Ministry to promote entrepreneurship culture and create awareness about schemes/initiatives of the Ministry amongst students & Youth through Audio/video film presentations. The Programme has been launched on 27.10.2021. Under the mass outreach programme, students of different colleges from all parts of the country are being encouraged to take up entrepreneurship. As on 02.12.2021, 61,481 students from various colleges across the country have participated in the National Level Awareness Programme. An amount of Rs. 28.89 lakh has been allocated to conduct 'Sambhav' e-National Level Awareness Programme, out of which expenditure of Rs 9.5 lakh has been incurred till date.
- (d): Under the Entrepreneurship and Skill Development Programme (ESDP) scheme, Ministry of Micro, Small and Medium Enterprises is conducting various training Programmes across the country to motivate youth representing different sections of the society including SC/ST/Women, differently abled, Ex-servicemen and Below Poverty Line (BPL) persons to consider self-employment or entrepreneurship as one of the career options. The training components of the ESDP scheme are: Industrial Motivation Campaign (IMC), Entrepreneurship Awareness Programme (EAP), Entrepreneurship cum Skill Development Programme (E-SDP) and Management Development Programme (MDP).

The detail of ESDP trainings conducted in the State of Tamil Nadu and Maharashtra are as follows:

Also, Ministry through its social media accounts regularly disseminates information on its initiatives/schemes and motivates youth to take up entrepreneurship.
