**MSME UNITS IN PUNJAB AND HARYANA**

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details of new Micro, Small and Medium enterprises set up in the State of Punjab and Haryana under programmes like Prime Minister's Employment Generation Programme (PMEGP) during each of the last three years and the current year;
- (b) the details of new Micro-Enterprises set up in the parliamentary constituency of Fatehgarh sahib, Punjab during each of the last three years;
- (c) the details of the funds sanctioned and allocated for the execution of such programmes during the last three years; and
- (d) whether the Government introduced new programmes to facilitate the setting up of new enterprises post COVID-19 lockdown and if so, the details thereof?

(a) to (c): Ministry of Micro, Small and Medium Enterprises is implementing Prime Minister's Employment Generation Programme (PMEGP), which is a major credit-linked subsidy programme aimed at generating self-employment opportunities through establishment of micro-enterprises in the non-farm sector across the country.

The details of funds allocated, funds utilized and micro enterprises set up in the State of Punjab and Haryana for the last three year and current year (up to 01.12.2021) are given below:

(d): The Ministry of Micro, Small and Medium Enterprises (MSMEs) implement various schemes for promotion and development of MSME sector in the country. These includes Prime Minister's Employment Generation Programme (PMEGP), Micro and Small Enterprises-Cluster Development Programme (MSE-CDP), Scheme of Fund for Regeneration of Traditional Industries (SFURTI), Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) and A Scheme for Promoting Innovation, Rural Industry & Entrepreneurship (ASPIRE).

Government has taken a number of initiatives under Aatma Nirbhar Bharat Abhiyan to support the MSME Sector in the country especially in Covid-19 Pandemic. Some of them are:

- i. Rs 20,000 crore Subordinate Debt for MSMEs.
- ii. Rs 3 lakh crores Collateral free Automatic Loans for business, including MSMEs (existing overall guarantee limit under ECGLS has been enhanced from Rs. 3 lakh crore to Rs. 4.5 lakh crore).
- iii. Rs. 50,000 crore equity infusion through MSME Fund of Funds.
- iv. New revised criteria for classification of MSMEs.
- v. New Registration of MSMEs through 'Udyam Registration' for Ease of Doing Business.
- vi. No global tenders for procurement up to Rs. 200 crores, this will help MSME.
