- (a) the details of works done under Smart Cities Mission in Madhya Pradesh;**
- (b) the details of funds sanctioned, allocated and spent for the said purpose so far;**
- (c) whether the Government is satisfied with the pace of the works being carried out and if so, the details and extent thereof; and**
- (d) whether all the works are likely to be completed on time and if so, the details thereof and the steps taken by the Government in this regard?**

(a) to (d): Government of India launched the Smart Cities Mission (SCM) on 25 June 2015. 100 Smart cities have been selected through

4 rounds of competition from January 2016 to June 2018. 7 cities in the State of Madhya Pradesh i.e., Bhopal, Indore, Jabalpur, Gwalior, Sagar, Satna & Ujjain have been selected for development as Smart Cities. Smart City-wise details of selection, progress of projects, funds released by Central Government & utilization thereof are given in Annexure-I. The period of implementation of SCM has been extended upto June 2023 and all Smart Cities are expected to complete their projects within the stipulated time.
