#### AUDIT OF MANUFACTURED AND ALLOCATED VENTILATORS

#### 2126. SHRI KESINENI SRINIVAS:

#### Will the Minister of **HEALTH &FAMILY WELFARE** be pleased to state:

- (a) whether the Government has undertaken an audit to ascertain if the ventilators manufactured and allotted to hospitals during the COVID-19 pandemic are functional and if so, the details thereof and if not, the reasons therefor;
- (b) whether the Government has mapped the allocation of such ventilators State/UT/ district-wise and at the hospital level, if so, the details thereof; and
- (c) the details of the ventilators allotted to State/UT/district-wise specifically to Vijaywada in Andhra Pradesh?

#### **ANSWER**

### MINISTER OF STATE IN THE HEALTH & FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a) An Independent assessment of Installation, Commissioning and Operation of ventilators was carried out. 35 Teams were constituted which physically visited the States/UTs. Each team comprised a representative each from Director General of Heath Service (Dte.GHS), Central Drugs Standard Control Organization (CDSCO) and HLL Lifecare Limited. The teams co-opted one member each from each user hospital and manufacturer whose ventilator is supplied in the hospital.

These 35 teams covered 606 Districts and 1699 hospitals in 35 States/Union Territories. 38729 "Make in India" ventilators were evaluated. As assessed during this exercise around 90% of ventilators were found to be functional and rest were made fully functional after some interventions by manufacturers of these ventilators.

(b) & (c) State wise allocation of Ventilators is made based on the demand projected by the States/UTs. Number of ventilators provided State/UT wise is enclosed at annexure. Allocation to Districts and Hospitals is made by the State Government. A total of 313 Ventilators were provided to District Vijayawada in Andhra Pradesh.
