Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- (a) the number of persons who have got training under Skill India Mission/Skill development programmes run by Government during the last three years, yearwise details thereof, especially in Tamil Nadu and Maharashtra;
- (b) the details of the names of the trusts/ agencies engaged in the implementation of the aforesaid schemes along with fund allocated by the Union Government to Maharashtra and Tamil Nadu for the above said schemes;
- (c) the number of such trained persons who have got employment during the said period in Tamil Nadu and Maharashtra;
- (d) whether the Government proposes to formulate any concrete action plan for the people who have been unsuccessful in getting employment? and
- (e) if so, the State-wise details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP (SHRI RAJEEV CHANDRASEKHAR)

(a) The Government is implementing various Skill Development Schemes/Programmes across Central Ministries/Departments, for providing a range of Skill Development training programmes on pan India basis. As per details available in respect of 11 major Ministries/Departments, about 40 lakh persons have been trained during last three years. Details of number of persons trained under the various schemes being implemented by the Ministry of Skill Development and Entrepreneurship especially in Tamil Nadu and Maharashtra during the last three years are as follows:

- (c) **Pradhan Mantri Kaushal Vikash Yojna (PMKVY):** Under PMKVY, 82359 persons were placed in Tamil Nadu and 51,627 persons were placed in Maharashtra in the last three years.
- (i) Jan Shikshan Sansthan (JSS) Scheme: This Scheme is implemented through Non-Governmental Organisations (NGOs) and aims at providing vocational skills to non-literates, neo-literates as well as school dropouts by identifying skills that have a market in the region of their establishment. The objective of training imparted under JSS is to link the individuals for gainful livelihood and supplement their family income through self-employment and wage employment. The providing of employment/placement to the beneficiaries is the not mandate of the JSS Scheme. As per available data, 87300 trainees under JSS have got self-employment/wage employment during last three years.
- (ii) **National Apprenticeship Promotion Scheme (NAPS):** This Scheme is for promoting apprenticeship training and increasing the engagement of apprentices by providing financial support to industrial establishments undertaking apprenticeship programme under The Apprentices Act, 1961. Training consists of Basic Training and Onthe-Job Training / Practical Training at workplace in the industry. Since NAPS is an apprenticeship related scheme, no placement is tracked.
- (iii) Craftsmen Training Scheme (CTS): Long term training programme in 137 trades are provided through 14,788 ITIs in the country. As per the report of the Tracer Study of ITI Graduates 2018 conducted by the Ministry of Skill Development and Entrepreneurship through Mott MacDonald, an Independent Agency, 63% of ITI Graduates are employed of which 6.7% are self-employed

Government has taken various steps for generating employment in the country like encouraging various projects involving substantial investment and increasing public expenditure on schemes like Prime Minister's Employment Generation Programme (PMEGP), Pt. Deen Dayal Upadhyaya Grameen Kaushalya Yojna (DDU-GKY), Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS), and Deendayal Antodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) run by Ministry of Micro, Small & Medium Enterprises, Ministry of Rural Development and Ministry of Housing & Urban Affairs, respectively. Under PMKVY 2.0 scheme of MSDE, training Centres take all efforts to facilitate placements of certified candidates through multiple initiatives like Rojgaar Mela, Yuva Sampark and Aatmanirbhar Skilled Employees Employer Mapping (ASEEM) portal, collaboration with industries and Council. Under present phase of the PMKVY i.e PMKVY 3.0, demand driven and bottom-up approach has been provisioned to boost demand for job roles which are prevailing at regional/local level. In addition, informed choices/aspirations of the candidates have been given primacy which aims to support the self-employment as well. This scheme also supports the vision of Atmanirbhar Bharat by encouraging candidates to opt for local skill with local jobs.
