SETTLEMENT OF AGRICULTURAL INSURANCE CLAIMS

2615. SHRIMATI VEENA DEVI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether the rate of settlement of agriculture insurance claims is very low in some States;
- (b) if so, the details thereof, State-wise including Bihar; and
- (c) the details of the insurance claim amount paid to the farmers for the crop damage for the last three years, State-wise?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) to (c): Pradhan Mantri Fasal Bima Yojana (PMFBY) is an yield index based scheme and mainly implemented on area approach basis. Claims are worked out on the basis of shortfall in actual yield viz-a-vis the threshold yield in the notified area as per given formula in the scheme. The quantum of claims under the scheme depends upon the happening of natural calamity/yield of the crop and may differ from crop to crop and area to area.

The scheme is voluntary for the States and the Bihar State Government is not implementing the PMFBY since 2018-19.

State-wise details of the insurance claim amount paid to the farmers during the last three years i.e. 2018-19 to 2020-21 under PMFBY are **Annexed**.
