**(a) & (b): Khelo India Scheme is a demand-driven scheme and the proposals are considered under this scheme on the basis of their feasibility with reference to the parameters of the scheme and availability**

**of funds. However, under vertical “Utilization and Creation of Sports Infrastructure” of Khelo India Scheme, 11 sports infrastructure projects amounting to ₹101.80 crore have been sanctioned in the State of Maharashtra. The detail of the said projects are at Annexure.**
