Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) the amount of funds invested by the Government in Jammu and Kashmir and Jharkhand in the food processing sector during the last three years; and
- (b) the amount of Foreign Direct Investment received by the Government in the said sector during the last three years, State-wise?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI PRAHLAD SINGH PATEL)

(a): Ministry of Food Processing Industries (MoFPI) does not set up food processing industries on its own. However, it provides credit linked financial assistance (capital subsidy) in the form of grants-in-aid to eligible entrepreneurs selected on the basis of Expression of Interest under relevant component schemes of Pradhan Mantri Kisan SAMPADA Yojana (PMKSY). PMKSY is not region or state specific but demand driven and is implemented across the country including in the state of Jharkhand and Union territory of Jammu and Kashmir. MoFPI is also implementing a Centrally Sponsored Scheme-PM Formalisation of Micro Food Processing Enterprises Scheme (PMFME) for providing financial, technical and business support for upgradation/ setting up of micro food processing enterprises across the country including Jharkhand and Jammu & Kashmir. The details of projects approved under PMKSY since 2018-19 and funds released under PMFME is placed at **Annexure-I**.

(b): Foreign Direct Investment inflow in Food Processing sector during last three years along with state-wise details is placed at **Annexure-II**.
