- (d) whether there is any proposal to increase the quota for Namakkal and Rasipuram stations in the above train;
- (e) if so, the details thereof; and
- (f) the steps taken by the Railways to eradicate mosquito problem in Karur, Namakkal and Rasipuram?

- (a) & (b) Yes, Sir. Due to poor patronization 22651 MGR Chennai Central-Palakkad Express does not stop at Rasipuram.
- (c) to (e) In Train No. 22651 MGR Chennai Central- Palakkad Express passengers of Namakkal (NMKL) and Rasipuram(RASP) stations can book tickets ex Namakkal by accessing following reservation quota:-

The above reservation quota is adequate to cater to the existing demand at the above locations. Further, as per extant practice reservation quota earmarked at various locations is reviewed periodically based on utilisation and adjustments made, wherever required, which is a continuous and ongoing exercise.

(f) Periodical antimalarial spraying of larvicidal and adulticides for mosquito control at Karur and stations of Namakkal and Rasipuram are done.

However, Concerned Authority, at Karur, has been advised to intensify the spraying work as and when required at Karur, Namakkal and Rasipuram as these stations are

surrounded by fertile lands where paddy cultivation is in abundance, hence stagnation of water is inevitable.
