PADDY PROCUREMENT

2967. SHRI ANUMULA REVANTH REDDY:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION उपभोक्ता मामले, खाद्य और सार्वजनिक वितरण मंत्री be pleased to state:

(a) the details of total paddy procurement done during the last 10 years, year-wise and State-wise;

(b) whether the Government has currently stopped paddy procurement at MSP from any State;

(c) if so, the reasons therefor;

(d) whether the Government has taken any steps to ensure that people get a fair price for their produce in the open market; and

(e) if so, the details thereof?

ANSWER

MINISTER OF STATE FOR MINISTRY OF RURAL DEVELOPMENT AND CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SADHVI NIRANJAN JYOTI)

(a): State-wise and Year-wise paddy procured at Minimum Support Price (MSP) for central pool during last ten years are at Annexure-I.

(b) and (c): Government of India has not stopped paddy procurement at Minimum Support Price from any State. Paddy procurement during Kharif Marketing Season 2021-22 (kharif crop) has commenced from October 2021 and till 08.12.2021, 326.00 LMT paddy has been procured in central pool.

(d) and (e): The estimates for procurement of Paddy (in terms rice) and wheat are finalized by Government of India in consultation with State Governments and Food Corporation of India, before the commencement of each marketing season based upon estimated production, marketable surplus and agricultural crop pattern.

Procurement in a State depends not only upon production but also upon other multiple factors like marketable surplus, MSP, prevailing market rate, demand & supply situation and participation of private traders etc.

State Government agencies and Food Corporation of India (FCI) purchase wheat & paddy with prescribed FAQ specifications at MSP for Central Pool to ensure that farmers get remunerative prices for their produce and do not have to resort to distress sale. . However, if producer/farmer gets better price in comparison to MSP, they are free to sell their produce in open market.

Due to various steps taken by the Government, procurement of paddy at MSP in central pool has increased significantly in last few years.
