#### NCD CLINICS IN NORTH-EAST REGION

# 3240. SHRI VINCENT H. PALA:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

(a) the number of Non-Communicable Disease (NCD) Clinics at District level set up in North East Region under the National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NPCDCS), State/UT-wise;

(b) the number of such clinics that are operational in Meghalaya; and

(c) whether the Government has conducted any financial and social audit of the NCD clinics to assess their performance and efficiency?

#### ANSWER

#### THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (DR. BHARATI PRAVIN PAWAR)

(a): Health is a state subject. The Department of Health & Family Welfare, however, provides technical and financial support to the States/UTs under the National Programme for Prevention and Control of Cancer, Diabetes, Cardiovascular Diseases and Stroke (NPCDCS), as part of National Health Mission (NHM), based on the proposals received from the States/UTs and subject to the resource envelope.

Under NPCDCS, the details of District level Non-Communicable Diseases (NCD) clinics set up in North-East Region are provided below:

(c) NCD Flexible Pool is under umbrella of NHM. Public Health is a state subject and its implementation primarily lies with the State Government. However, under National Health Mission (NHM), the following audit mechanisms are in place:

- Performance Audit by the Comptroller and Auditor General (CAG) of India,
- Annual Statutory Audit by Chartered Accountant firms empanelled with CAG and eligible for conducting audit of major PSUs
- Concurrent Audit by Chartered Accountants Audit firms.
