ALLOCATION OF FUNDS TO AYUSH INDUSTRY GROUPS/CLUSTERS

Will the Minister of **AYUSH** be pleased to state:

- (a) whether the Government has allocated funds for the development of AYUSH Industry Groups/Clusters;
- (b) if so, the details thereof;
- (c) the targets set and number of such groups/clusters developed at present, State-wise and district-wise, particularly in Chhattisgarh; and
- (d) the number of groups/clusters targeted to be set up by the Government particularly in Chhattisgarh and number of clusters out of these constructed under the scheme?

ANSWER THE MINISTER OF AYUSH (SHRI SARBANANDA SONOWAL)

(a) & (b): Yes, Sir. Ministry of Ayush (erstwhile Department of Ayush) implemented a Central Sector Scheme for Development of Ayush Clusters up to 12th Plan period (2012-17). The Government sanctioned funds to ten Ayush Industry Clusters under the said scheme. Later on, the scheme has been discontinued with effect from 01.04.2017. The details of Industry Clusters along with funds allocated are furnished at **Annexure**.

(c) & (d): Since the scheme has been discontinued with effect from 01.04.2017, at present, the question of setting targets does not arise. Further, no Industry Cluster was developed in the State of Chhattisgarh.
