FUNDS TO CHILD CARE INSTITUTIONS

3409. SHRI SUNIL KUMAR MONDAL : SHRIMATI CHINTA ANURADHA :

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) the number of Child Care Institutions (CCIs), State/UT-wise particularly in Andhra Pradesh;
- (b) the details of funds allocated for the maintenance of these institutions;
- (c) whether the Union Government has provided additional financial resources to CCIs for provision of additional items such as sanitization supplies, protective gear, medication, additional nutrition to boost immunity, additional clothing and bedding, capital costs to add infrastructure and equipment to ensure health and safety of children;
- (d) if so, the details thereof, State/UT-wise and if not, the reasons therefor; and
- (e) whether the Government has undertaken additional measures to protect and educate slum dwelling/ displaced children in light of COVID-19 pandemic?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) The State/UT-wise number of Child Care Institutions including Andhra Pradesh is at **Annexure-I.**

(b) Details of the funds released to the States/UTs under the Child Protection Services scheme during the year 2020-21 is at **Annexure-II**.

(c) & (d) During the FY 2020-21, an amount of Rs. 70977.53 lakhs was released to the States/UTs under Child Protection Services scheme which include the component of Swachchata Action Plan for provision of sanitisation, clean drinking water hand wash, etc. The details of funds released to the States/UTs under Child Protection Services scheme including 'Swachchata Action Plan' is at **Annexure-II**.

(e) States/ UTs have been requested for taking immediate action for care and protection of children adversely impacted by COVID 19, in accordance with the provisions of the Juvenile Justice (Care and Protection of Children) Act, 2015 and Rules thereunder, while leveraging the facilities funded under the Child Protection Services scheme. The Ministry also issued advisories and guidelines for encouraging COVID appropriate behaviour, monitoring of Child Care Institutions and coping strategies during COVID times for mental health support to children and care givers. A responsibility matrix defining role of primary duty holders at all levels from State to Panchayati Raj Institutions was also shared with States/UTs.
