**TRANSFORMING SHCS, PHCS INTO AYUSHMAN BHARAT - HEALTH AND
WELLNESS CENTRES**

3425. SHRI KALYAN BANERJEE:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to State:

- (a) whether the Government proposes to transform sub-health centres and primary health centres into Ayushman Bharat Health and Wellness Centres (AB-HWCs) for providing comprehensive primary health care with a view to promote minimum care approach;
- (b) if so, the details thereof and the financial and other assistance/support provided to states for the purpose, State-wise;
- (c) whether the AB-HWCs have been able to deliver the expanded range of services to address the basic primary healthcare needs of the entire population at community level and if so, the details thereof; and if not the reasons therefor; and
- (d) the necessary steps taken/proposed to be taken by the Government to deliver the provision of Comprehensive Primary Health Care?

(a) to (d):

As per the budget announcement 2017-18, 1.5 lakh Sub-Health Centres (SHCs) and Primary Health Centres (PHCs) are to be transformed into Health and Wellness Centres (HWCs) by December, 2022.

“Public Health & Hospitals” is a State subject, hence, the primary responsibility of providing comprehensive primary health care to all the citizens of the country lies with respective State Government. However, the States and UTs are supported for transformation and operationalization of Health & wellness Centres with an aim to provide Comprehensive Primary

Health Care (CPHC) that includes effective, affordable, quality and accessible healthcare at the community level with continuum of care approach primarily under National Health Mission (NHM) and also under recently launched PM-Ayushman Bharat Health Infrastructure Mission (PM-ABHIM). The details of State-wise financial support provided under NHM and PM-ABHIM is attached at Annexure-I.

AB-HWCs provide Comprehensive Primary Health Care (CPHC) through the range of 12 expanded health services package, closer to community. These primarily include Reproductive and Child Health (RMNCHA+N) services, Communicable Diseases, Non-Communicable Diseases (NCDs) (screening and management for NCDs such as Hypertension, Diabetes and 3 common cancers of Oral, Breast and Cervix) and incrementally adding other services for mental health, ENT, Ophthalmology, oral health, geriatric and palliative health care and trauma care etc. AB-HWCs also conduct various wellness related activities like Yoga, Zumba, Shirodhara , Meditation etc. which will enable improved physical and mental health. As on 15th December, 2021, more than 80,764 AB-HWCs are operational. In these AB-HWCs:

- Footfalls of more than 74.91 crore. Out of this, 53.7% are women
- Screening of 15.35 crore individuals for hypertension and 12.68 crore for diabetes
- Screening for three common cancers which include oral cancer (8.20 crore screenings), breast cancer (4.08 crore screenings in women) and cervical cancer (2.77 crore screenings in women) done across the country
- More than 91.51 lakh Yoga / Wellness sessions have been conducted so far.
