'Loans Given to Telangana'

No. 3651. Shri Anumula Reventh Reddy:

Will the Minister of Finance be pleased to state:

- (a) the details of loan given to Telangana by the Reserve Bank of India (RBI), External agencies under Externally Aided Projects and refinancing institutions of the Government during the last five years, year-wise;
- (b) the details of repayment of principal and interest by Telangana to these lending institutions during the last five years, year-wise;
- (c) the details of total public debt of Telangana which is outstanding as of 30th November, 2021; and
- (d) the estimated amount of principal and interest to be paid by Telangana towards the outstanding dues during the financial year 2021-22, 2022-23 and 2023-24, lending institution-wise?

ANSWER

THE MINISTER STATE IN THE MINISTRY OF FINANCE (SHRI PANKAJ CHAUDHARY)

- (a) (i) The Reserve Bank of India has not provided any loans to the Government of Telangana. However, RBI facilitates financial accommodation in the form of Special Drawing Facility, Ways & Means Advance and Overdraft to supplement the temporary mismatches between receipts and payments. Further, in the last five (5) years, no loan was extended by any external agency or refinancing institution to the Government of Telangana.
 - (ii) Additional Central Assistance for Externally Aided Projects released to Telangana for the Financial Year 2016-17 to 2021-22 (upto 13.12.2021) is annexed as Table-I.
- (b) Principal repayment and interest paid during last five (5) years on outstandings, upto 12.11.2021 is annexed as Table-II.
- (c) The Public debt of Telangana as on November 30, 2021 stands at `2,37,747 crore (`2,34,912 crore internal debt and `2,835 crore external debt).
- (d) The estimated amount of Principal and interest payable by Telangana is annexed as Table-III.
